STIPULATION TO EXPUNGE CRIMINAL HISTORY RECORD

We, the undersigned Defendant and State’s Attorney, hereby agree that the offense(s) meet the requirements for expungement pursuant to 13 V.S.A. §7602 and that the Court may issue an Order to expunge the criminal history record for the offense(s) described below:
