MOTION FOR REINSTATEMENT AFTER SUSPENSION
A.O. 9 RULE 26(D)

NOW COMES Daniel W. Ewald, by and through his attorney, John J. Boylan, III, and requests the Vermont Professional Responsibility Board (PRB) to order that his license to practice law in the State of Vermont be reinstated upon the expiration of his period of suspension which is September 6, 2025.

1. Pursuant to the terms of Decision No. 258 issued by Hearing Panel No. 6 dated February 6, 2025 and the confirming Entry Order of the Vermont Supreme Court in the above matter the license of Respondent to practice law in the State of Vermont was suspended for a period of six months effective as of March 6, 2025.

2. The provisions of A.O. 9 Rule 26(D) state that an attorney suspended for more than six months may request license reinstatement by the PRB by filing a motion not sooner than three months before expiration of the period of suspension and serving the motion on the Professional Responsibility Board and Disciplinary Counsel.


3. In support of this motion, Respondent represents that he has the moral qualifications, competency and learning required for re-admission to practice law in the State of Vermont and that reinstatement of Respondent's license will not be detrimental to the integrity and standing of the Bar or the administration of justice, nor would it be subversive of the public interest and that the Respondent has been rehabilitated.

4. Respondent notes that when his license to practice law in the State of Vermont was suspended, Respondent possessed a license to practice law in Vermont valid through June 30, 2026.

5. A copy of this Motion is being served this same date upon Disciplinary Counsel as required by A.O. 9 Rule 26(D).


