**PROPOSED SCHEDULING ORDER**

The parties in the above-referenced matter stipulate that the Panel may order the scheduling order setting forth the following deadlines for the parties:

1. Exchange the names and addresses of all persons having knowledge of relevant facts and/or of witnesses by September 29, 2025.
2. Serve requests for production of documents and evidence by September 29, 2025; Respond by October 13, 2025.
3. Take depositions by October 13, 2025.
4. Discovery shall be complete, including discovery-related motions by October 13, 2025.
5. File objections to the hearing panel conducting the merits hearing remotely by video conferencing September 22, 2025.
6. File pre-hearing motions, including motions *in limine* by October 13, 2025.
7. File a witness list identifying the witnesses the party anticipates calling to testify at the merits hearing, together with a brief summary of each witness's anticipated testimony and an estimate of the amount of time needed for direct examination, and an exhibit list identifying the exhibits the party anticipates presenting at the merits hearing, together with a representation as to whether or not the opposing party stipulates to each exhibit's authenticity or admissibility or both by October 13, 2025.


