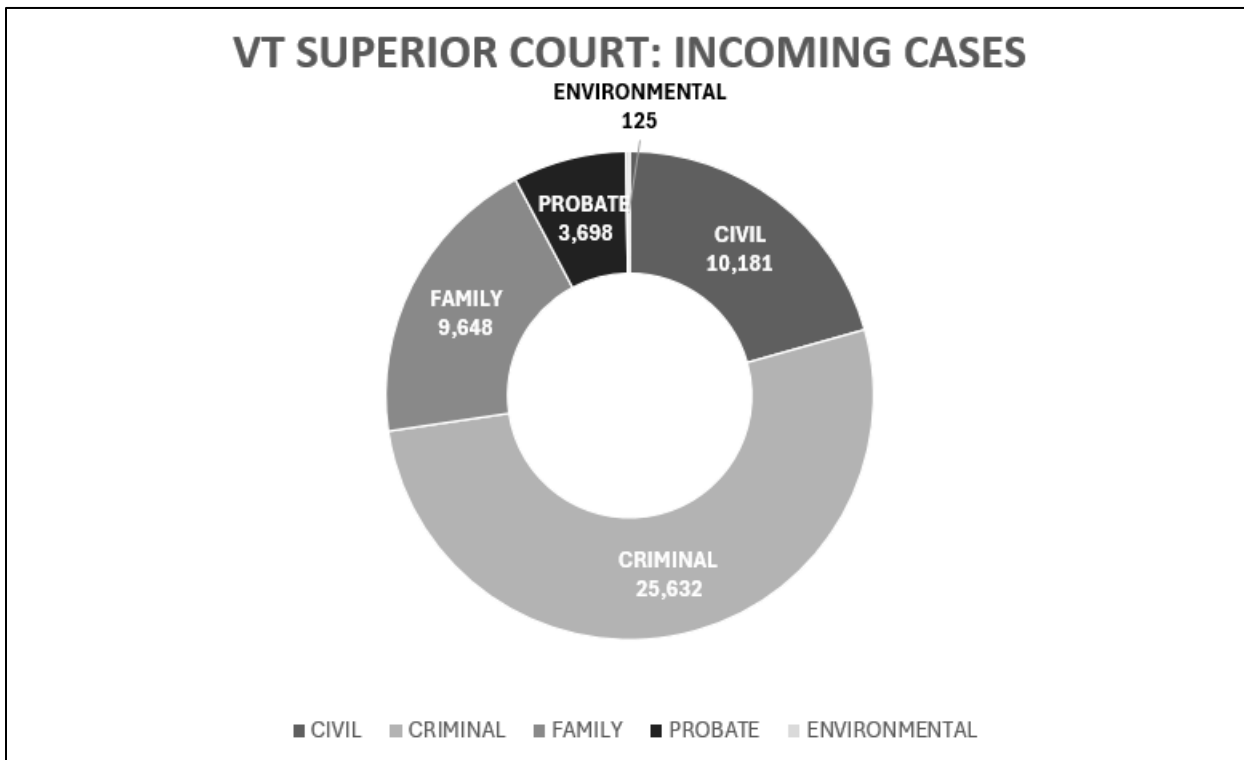

Highlights: Incoming Cases

There were 49,284 incoming cases in the Vermont Superior Court (criminal, civil, family, probate, and environmental divisions) in FY25. This includes new filings, reopened cases, and reactivated cases. This represents a 7% increase from the previous year.

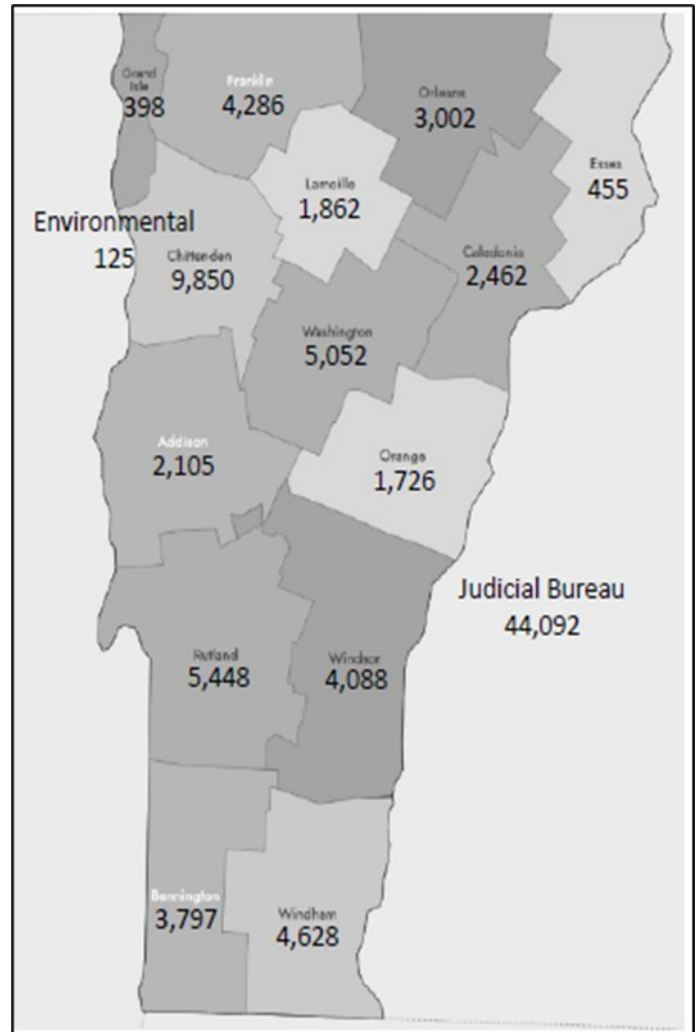
In addition:

- 2,927 investigative requests were filed in the criminal division, a 3% decrease from the previous year.
- 4,444 administrative matters were filed in the probate division, a 3% increase from the previous year.
- 44,092 cases were filed in the Judicial Bureau, a 3% increase from the previous year.



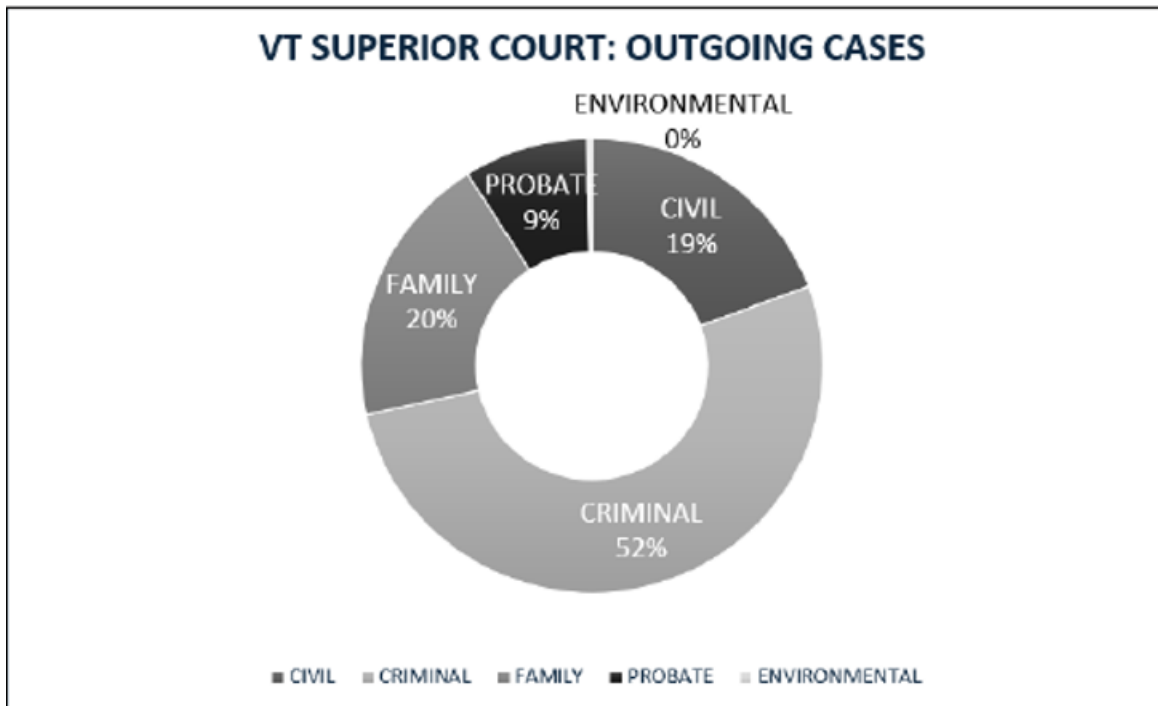

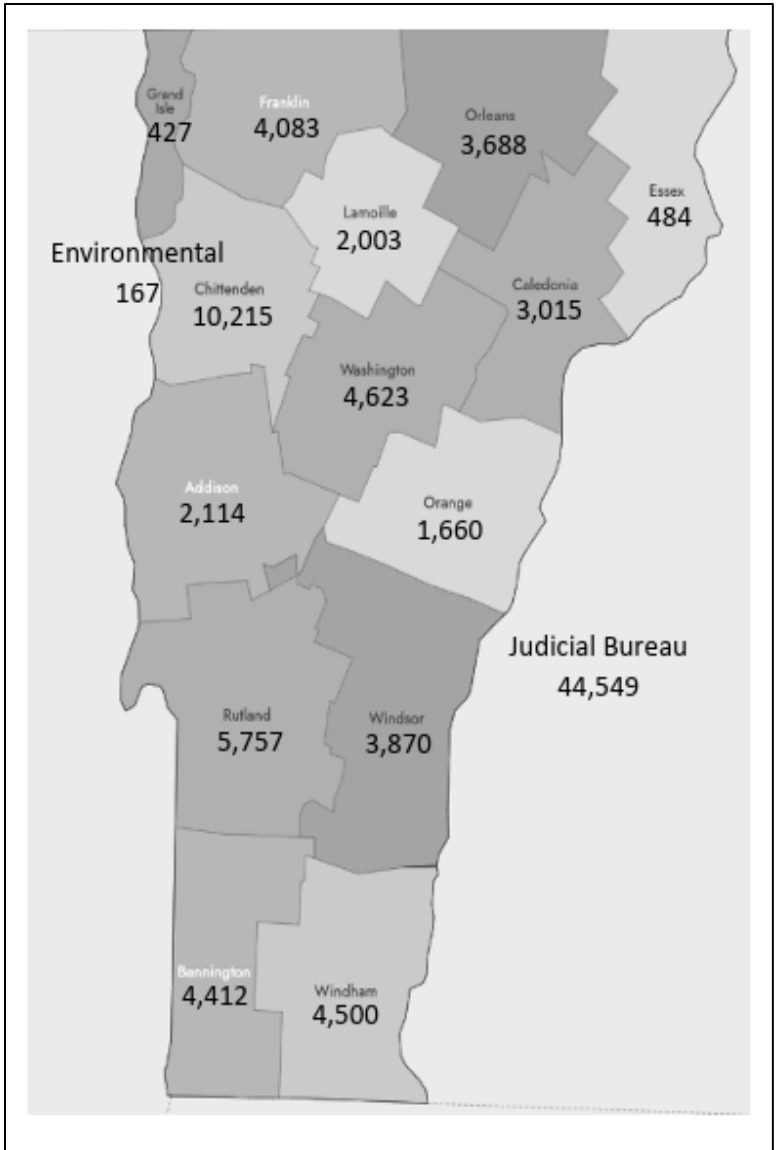
Highlights: Outgoing Cases

There were 51,018 outgoing cases in the Vermont Superior Court in FY25. This represents a 5% increase from the previous year. In addition, there were 2,944 investigative requests disposed in the criminal division, a 6% decrease from FY24. There were 4,368 administrative matters disposed in the probate division, a 2% increase from FY24. 44,549 matters were disposed in the Judicial Bureau, a 5% increase from the previous year.

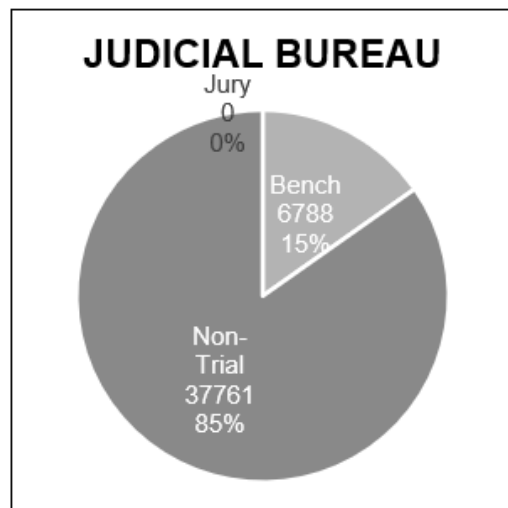
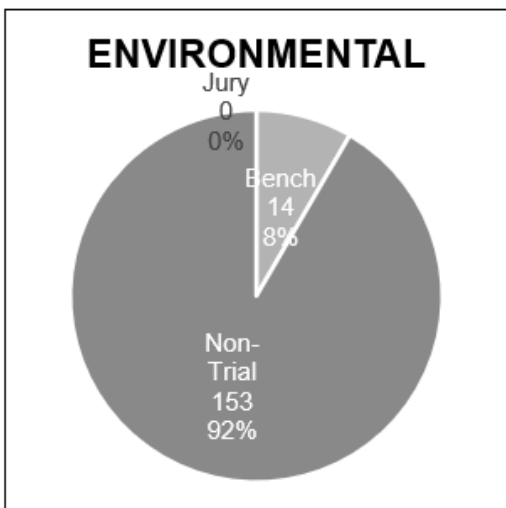
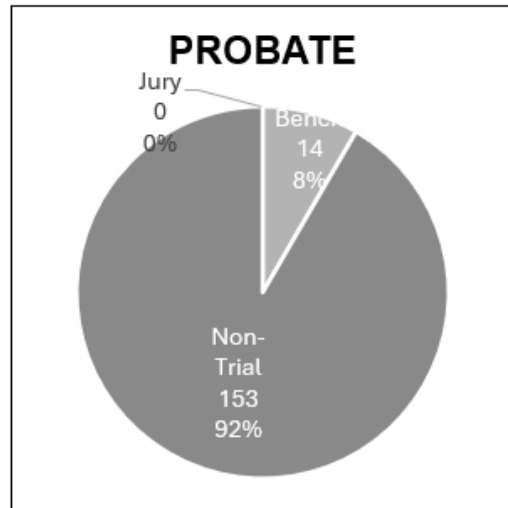
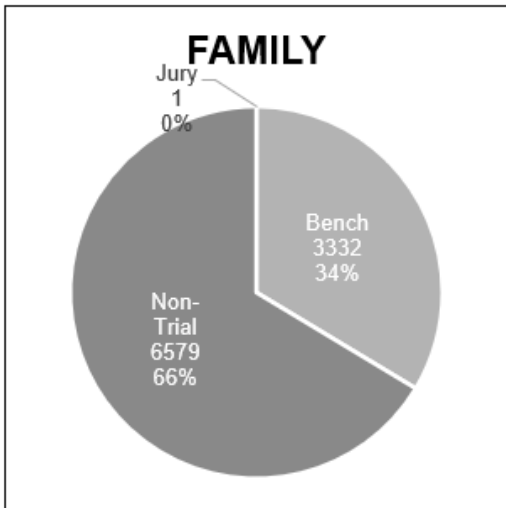
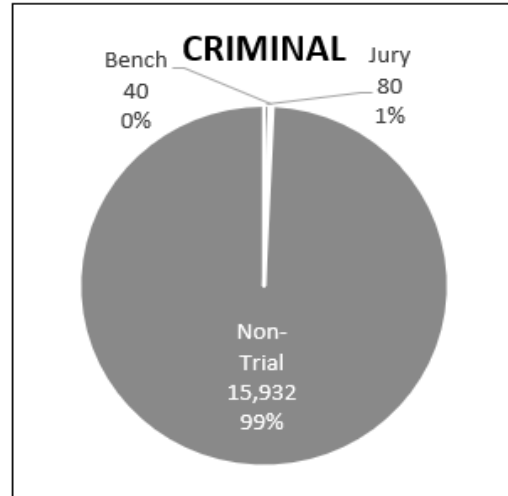
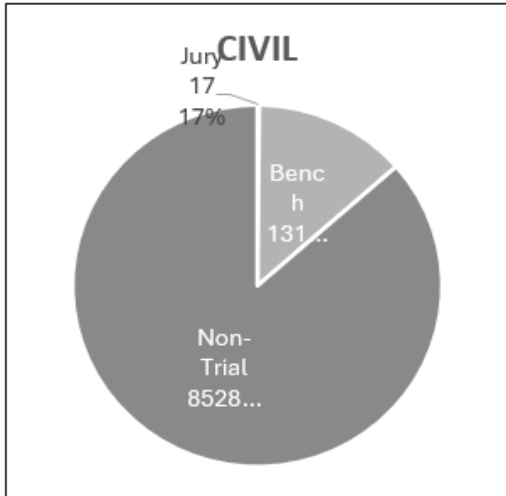

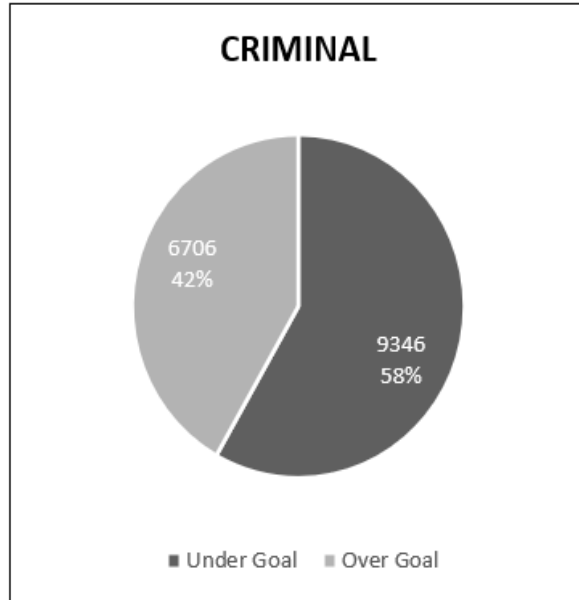
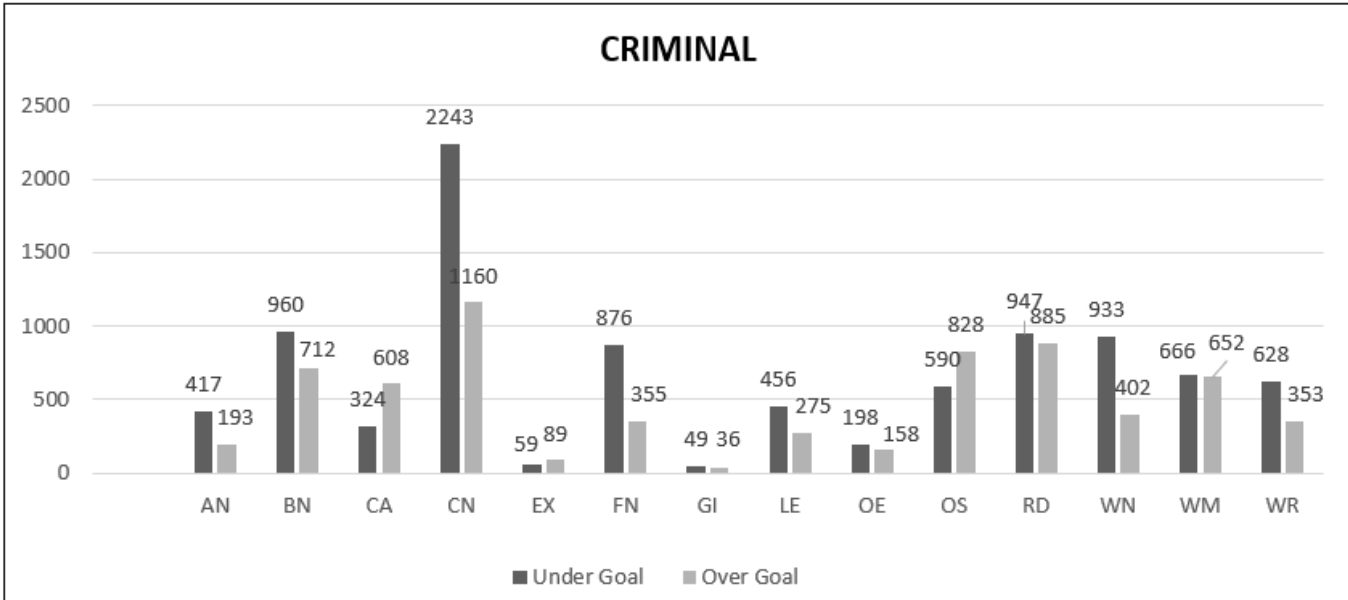
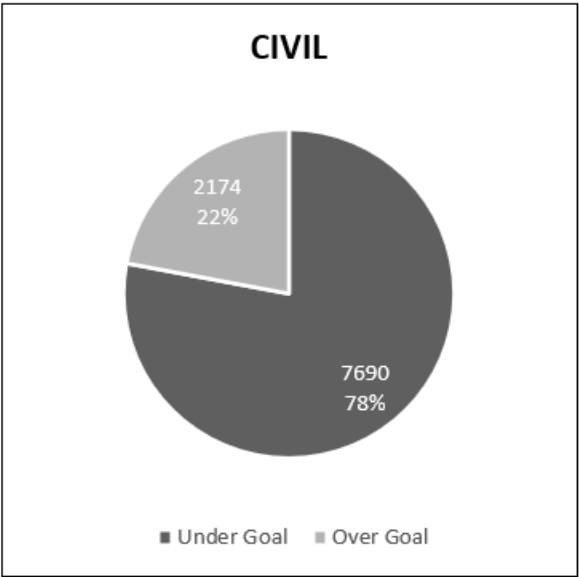
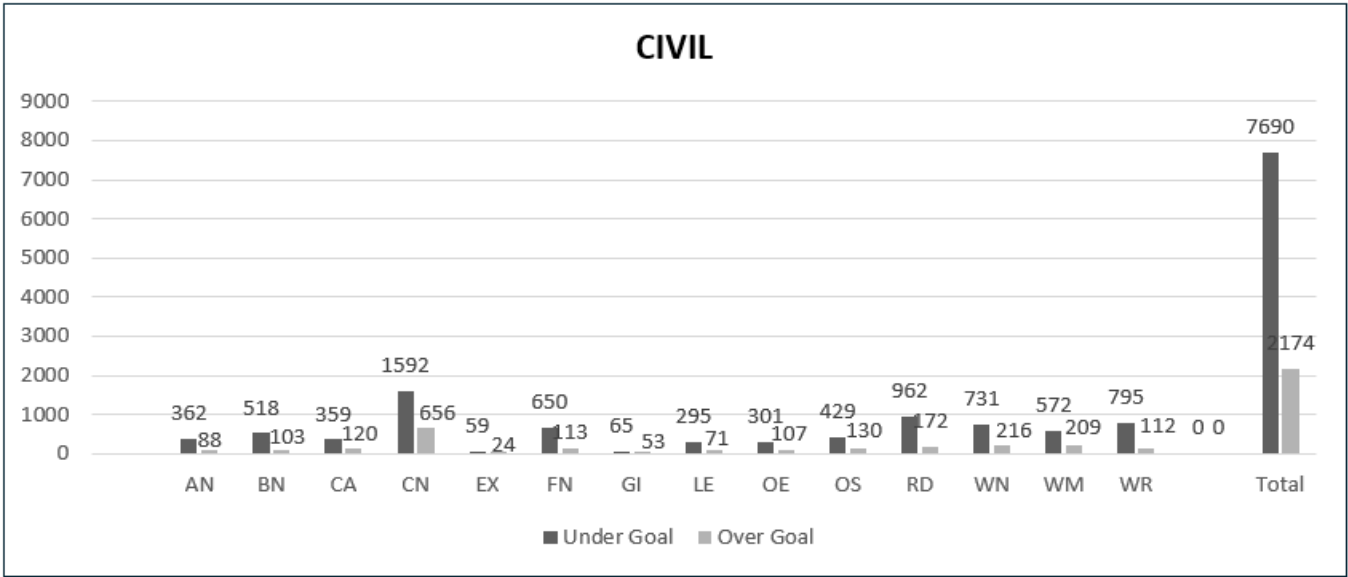


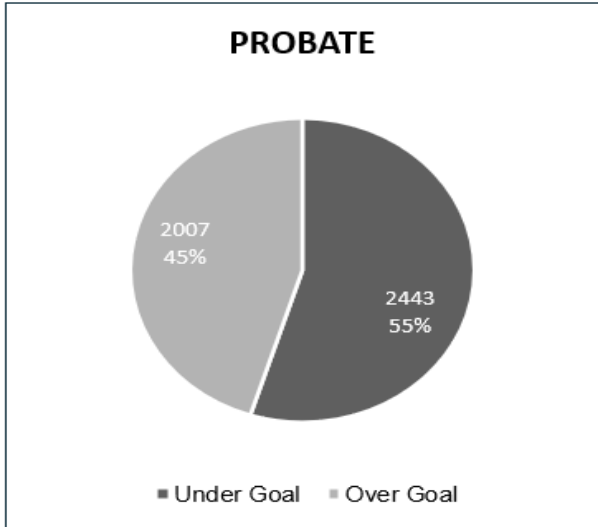
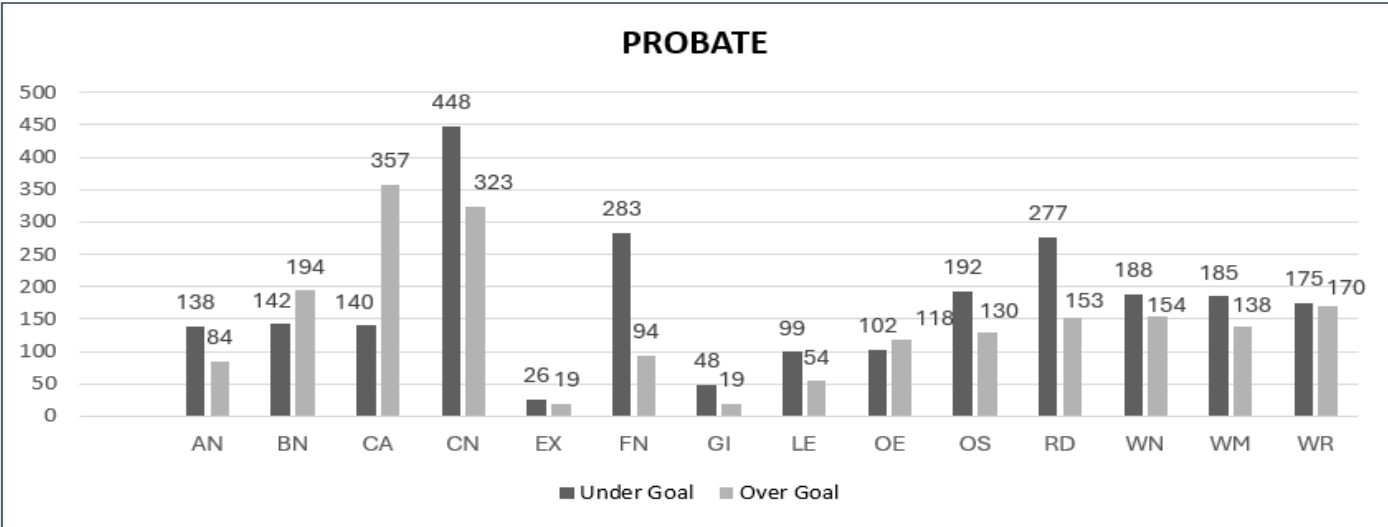
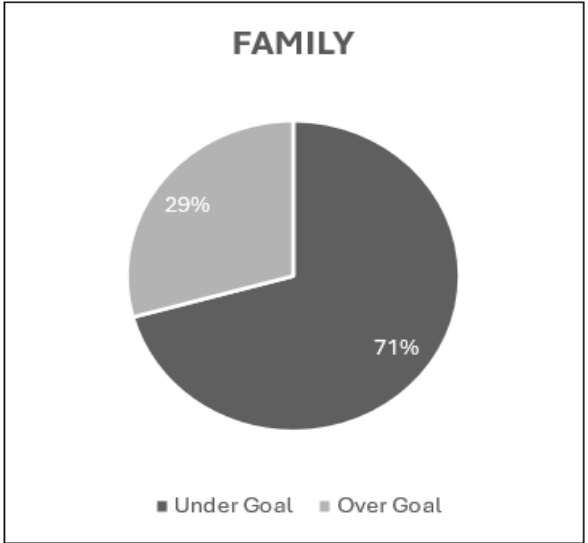
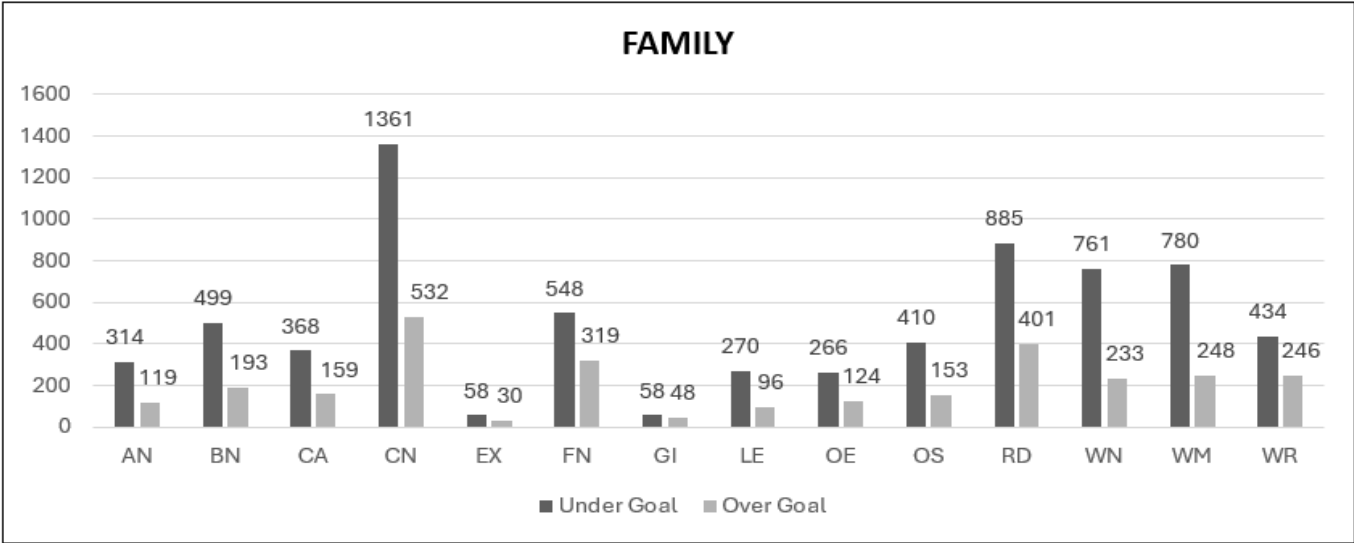
FY25 OUTGOING CASES: METHOD OF DISPOSTION



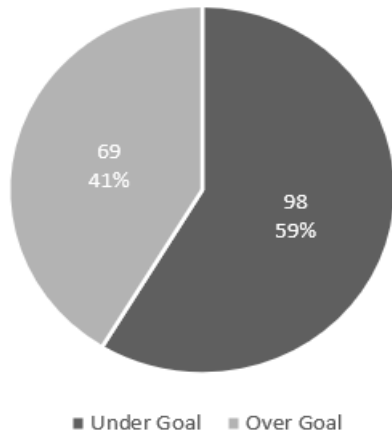

TIME TO DISPOSITION

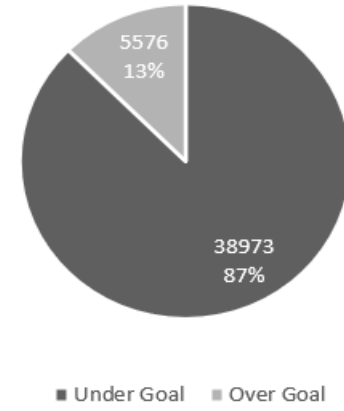




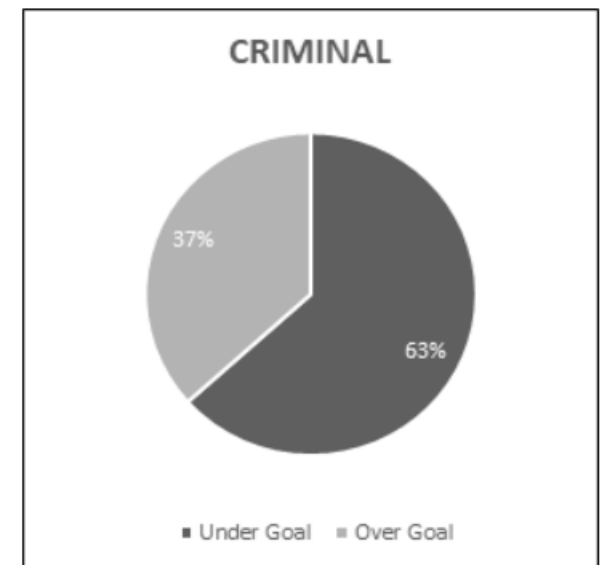
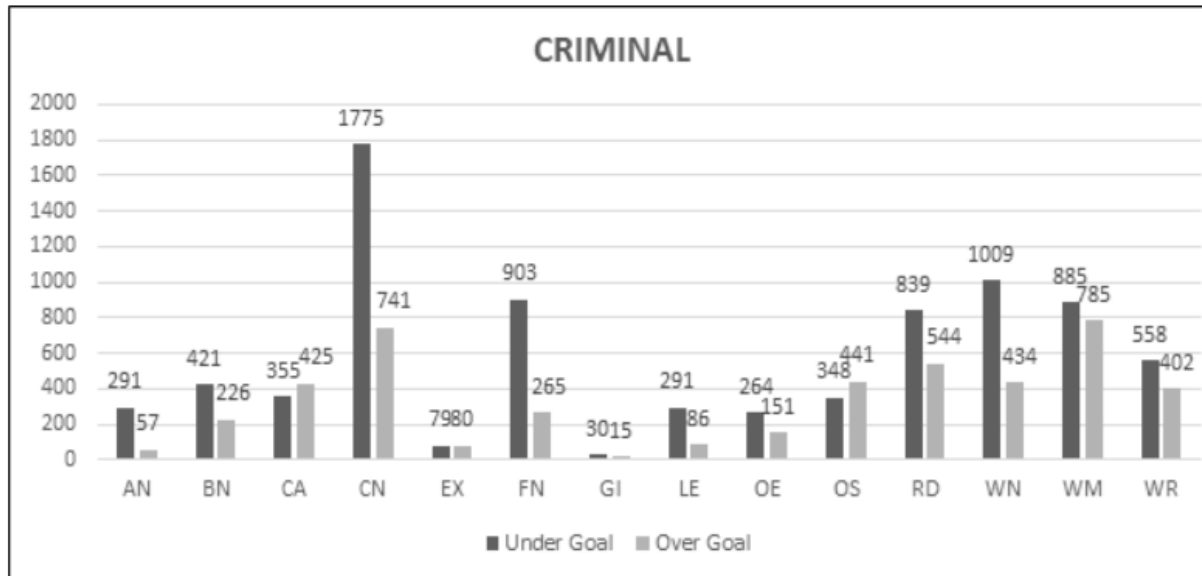
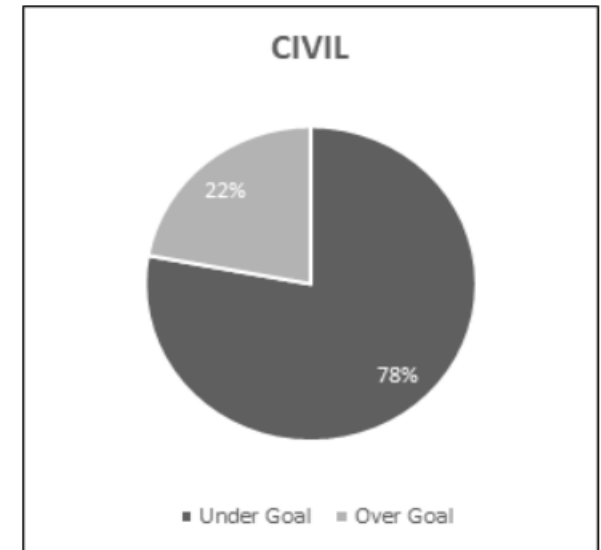
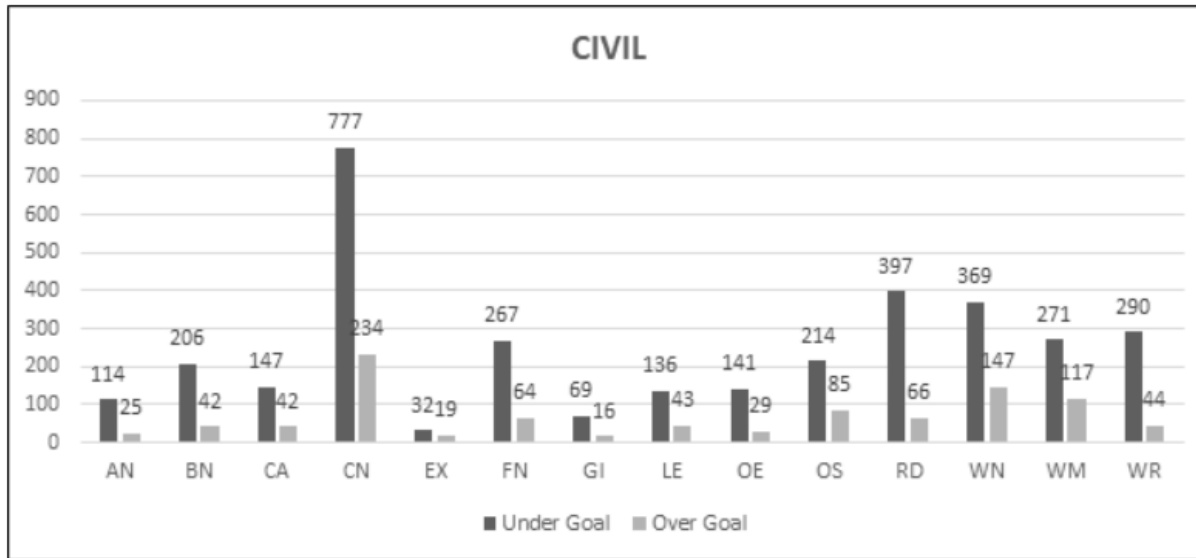
